

NSAA Parent/Student Agreement for Online Learning

All NSAA students [and parents] enrolled at NSAA are required to agree to the following online instruction conditions of enrollment. Failure to comply with this agreement may result in being dropped or losing credit.

I, _____ [student name] do hereby agree to accept the terms and consequences set forth in this agreement. The terms are as follows:

Attendance and Commitment:

I agree to join the Remind App. for all NSAA classes. A complete Remind code course list can be found on the school website.

- I commit to active learning by attending all classes at the scheduled time. The class period and time schedules for both High School and Middle School are attached in Addendum A.
- I understand that I will receive a Zoom class URL and password for each class meeting. I agree to save or bookmark the class URLs and passwords for easy access.
- I agree to have 2-way communication with my course instructor every day the class meets.
- I understand that attendance will be taken each day the class meets via the Zoom platform. If I am unable to join a class on a given day and/or time, I agree to message my instructors on Zoom or Remind to receive any missing assignments.

Parent/Guardian Commitment

- As a parent/guardian, I agree to monitor and support my child in his/her studies, agree to be accessible to each course instructor to discuss my child's progress, and promote good attendance and time management for my child.
- Ensure my child has technology to support this platform.

Acceptable Use Policy

- I agree to participate in program activities in a positive manner and follow rules, including the student handbook and other policies as set forth by NSAA administration and instructors.

- I understand that anything I do in the course(s) can be retrieved and monitored by the teacher and administration at any time.

Technology

- I acknowledge that I have a computer and Internet access and am capable of getting daily access to NSAA instruction through the Zoom platform. In the event I experience technology issues, I will contact my instructors or school administration by phone.
- I understand I will have my own personal gmail account to use for turning in work.

Grading & Transcripts

- All final scores provided by the instructor will be documented in each instructor's gradebook and can be accessed via the Family Link. Both attendance and daily grades will be part of my course grade which will be included in my cumulative grade point average (GPA).

Cheating/Plagiarism

- I understand that cheating is considered a serious academic offense, and agree to abide by the following rules:

Examples of cheating include, but are not limited to:

- ❖ Unauthorized sharing of test answers.
- ❖ Unauthorized sharing of class assignments or homework.
- ❖ Plagiarism.

For the purpose of this offense, plagiarism is defined as: the unauthorized representation of another's work as one's own. In addition, any unethical practice which compromises the integrity or teacher's intent of an assignment, test or quiz such as (but not limited to) the use of unauthorized resources (calculator, teacher materials, textbooks, another learner's work, etc.) shall be deemed to be cheating or plagiarism.

- Disciplinary action for cheating/plagiarism is as follows:
 - ❖ First offense – Loss of grade for assignment, parent and administration informed.

- ❖ Second offense – Loss of grade for assignment, suspension from class until a conference is held with parent and administration, and possible failure of course.
- ❖ Third offense – Automatic failure/loss of credit for course.

Agreement Violation Consequences

- 1st offense: Verbal warning. Parents and administration notified.
- 2nd offense: Written warning. Parents and administration notified. Possible removal from the course.
- 3rd offense: Removal from NSAA.
